HOW TO ENTER: Go to www.Crowdrise.com (the "Website") and follow the on-screen instructions to make a donation of at least \$25 during the Sweepstakes Period to the "Real Men Don't Buy Girls" project (<http://www.crowdrise.com/supportdna/fundraiser/ashtonkutcher>) on Crowdrise and you will be automatically entered into the Drawing (defined below) for the Crowdrise Sweepstakes – Win a No Strings Attached Movie Poster Signed by Ashton Kutcher."

ONLINE ENTRIES MUST BE RECEIVED BY December 20, 2010 at 11:59pm eastern time. No illegible, incomplete, forged or altered entries will be accepted. All entries become the exclusive property of Sponsor and will not be returned.
